It's Rubbish! – Littering and Fly-Tipping still a Concern...

Talking Trash...

Littering and fly-tipping – anti-social and inconsiderate acts that have a detrimental, destructive impact on our environment – are still causing concern in the Parish.

The **Council's** attention has again been drawn not only to the **increasing amount of roadside litter** apparently discarded from cars, but also to a continuation of what appears to be **deliberate acts of fly-tipping**.



The above cache of cans and bottles was recently discovered fly-tipped near the **Alderford Farm/ Hedingham Road** junction; this is obviously not just a case of casual, thoughtless littering...

You can help the **Council** address this problem by notifying the **Parish Clerk – in confidence** – of any suspicious littering or fly-tipping activity you see. All the information you can provide, on the cars involved or the location, together with photo evidence of the litter, if possible, will be forwarded to the police for follow-up action.

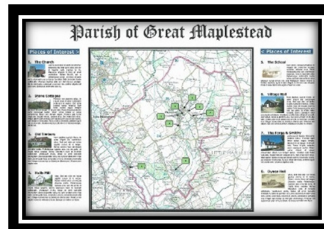
The standard penalty for a littering offence is £75, although persistent offenders can be fined up to £2,500.

Village Information Board



The Council now has agreed funding to install a **Village Information Board at the entrance to the Playing Field.**

The board will be an oak-framed A1 (840mm x 575mm) sized, lectern-style one, with a two-post mounting, as illustrated above. Its purpose is to provide visitors, and residents, with details of the local sights, features and footpaths.



The information panel will be printed and encapsulated in low maintenance, graffiti-resistant plastic, reinforced with glass – this material offers exceptional durability and water resistance, is colour-fast and stands up well against scratches.

The final design and content of the information panel is currently being decided – although a map of the Parish will be the central feature.

Wig-Wags are 'Go'...



The long-awaited flashing wig-wag warning signs (left) were finally installed for the start of the **School's spring term.**

These new solar-powered signs have replaced the previous versions on all three approach roads to the School.

The signs display an **advisory 20mph limit**, applicable when the lights – activated by an automatic timer for an hour each weekday morning and evening during pick-up and drop-off times – are flashing.

The speed limit reverts to a **statutory 30mph** at all other times.

Spreading the Word...

One of the **Parish Council's** initial aims was to improve the way that information about the Parish and the **Council's** activities could be made available to parishioners.

This resulted in the launch of this newsletter, to better communicate – and enable residents to keep abreast of – affairs of current interest.

It also prompted the on-going improvements to the content and quality of the information contained on the **Council's** website.

Now the need for a **Community Information** leaflet – a core document containing details of, and how to access, the many **services and activities** provided by the Parish – has been identified.



The leaflet – intended to benefit existing residents and to be an **essential source of information** to newcomers to the village – will also highlight, and contain details of who to contact about, the **community help** available to parishioners.

It is planned to hand-deliver a copy of the **Community Information** leaflet to each household during the spring.

Bird Flu – Taking Precautions

To help minimise the spread of the current avian flu outbreak, all poultry keepers, by law, must house or enclose their birds.



These restrictions apply to **all** poultry – **whether kept on a commercial scale or just as a small backyard flock.**

The legal restrictions were recently extended until **28 February 2017**. Poultry keepers are also being encouraged to keep a close watch on the health of their birds.

Risks to public health are very low and avian flu does not pose a food safety risk.
