The Playing Field Development Project – have your say...

...and make a contribution

The Council Working Party tasked to create a plan to develop the Playing Field in a way that will ensure its future safety and sustainability will be presenting its Development Project proposals at two public meetings to be held in the Village Hall on Saturday 22nd May.

These one-hour presentations – at **10.00am** and **2.00pm** – will explain what the plan is aiming to achieve, the longer-term community benefits and how it is intended that the project will be funded. The meetings will **enable you to play an active role** in the biggest community scheme since the play equipment was first installed 25 years ago.

The **Working Party** is proposing that funding be sought to carry out:

- 1. A redesign of the playground, with the complete renewal of its equipment (the illustration below is **just an initial idea, not an approved plan**)
- 2. The installation of new field drains to improve surface conditions after heavy rainfall
- 3. The construction of a Boules Court and provision of additional picnic benches, for which partial grant funding has already been received

It is estimated that about **£55,000** will be required to deliver the **Development Project** in its entirety.

How will the project be financed?

The **Working Party** has identified five potential funding sources for the project: the **Council**'s own reserves; income from events; crowd-funded donations; sponsorship from local businesses and individuals; grants from local/national agencies.


The **Council** has already taken the initiative by investing some **£2,000** of its reserves to kick-start the scheme. This money will be added to the grant already received to purchase and install the Boules Court and picnic benches, enabling these additional facilities to be available for use later this summer.

How you can help

The **Working Party** is now putting together further grant requests to submit to various local/national funding agencies. However, since **match-funding** is needed to help most applications succeed, the project needs to secure initial financial support from local businesses, institutions and individuals.

The meetings will therefore also offer opportunities to explore the **crowd-funding**, **sponsorship** and **business investment** potential within the parish.

Half-Term Report

The Parish Council is now half-way through its 4-year term – its main accomplishments since May 2019 are detailed below:

Playing Field:

- Security measures were installed to guard against traveller incursions (further work to install a bund/ carry out wildflower seeding will be scheduled soon). The car park was resurfaced, some play equipment
- was replaced and the waste bin repaired. A funding grant was applied for and has been received
- for a Boules Court/additional picnic benches.
- The Terms of Use sign was re-sited at the entrance.

Footpaths:

- A new footbridge was installed across the brook at the bottom of Reyes Hill, broken planks on the footbridge from the water meadows to Lucking St were replaced and loose planks were refitted/replaced on the Slype Copse footbridge.
- The Slype steps were replaced by a 'causeway' slope, circumventing the marshy area of the previous path.
- Some broken risers on Church Field steps were replaced and a collapsed fence/fallen tree blocking the Hulls Mill footpath were re-erected/removed.

Communications:

- A Council Facebook page was created to improve dialogue with, and feedback from, parishioners.
- A Parish survey was carried out to obtain feedback on the telecommunication mast plans.

Highways:

- The Lucking Street drainage project, initiated in 2017, was finally undertaken and completed by ECC.
- A road safety programme has been initiated with ECC - confirmation of budget approval is awaited.
- A new dog bin was installed in Gestingthorpe Road.
- Ad hoc litter picks have been undertaken, including sponsorship of a volunteer working for her bronze Award on the Duke of Edinburgh's Award scheme.

Community Projects:

- The Council's Community/Emergency Information leaflets have been reviewed and updated.
- A working liaison has been established with the local PCSOs and their Community Policing Programme.
- The defibrillator stolen from the Village Hall was replaced, with improved security measures, and a CPR/Defibrillator training/refresher course held.
- A Covid Community Support initiative (Village Support Group) was established to help vulnerable residents.

General:

- The Council was presented with a second Foundation Award Certificate, recognising that it meets all the criteria for operating both lawfully and in accordance with **best practice** - it is valid until 2023.
- Emergency Standing Orders were introduced to enable work and meetings to continue uninterrupted.
- Planning Applications have continued to be monitored _ and responded to, including Kofali Farm's plans for a development on the field alongside Purls Hill.
- Monitoring of the Local Development plan continues.
- A new audit process has been implemented and the Council's financial reserves successfully maintained
