# **Playing Field Development Project wins lottery funding!**

# Now it's all systems go...

The Playing Field Development Working Party recently received some very welcome news: its £75,000 application to the National Lottery Community Fund to help fund the Parish Council's ambitious Playing Field project has been successful!



This sizeable grant, together with the £37,000 already raised through generous personal donations from residents, contributions from village institutions, businesses and various social events over the last 18 months, means that this major project for improving and future-proofing a unique, valuable village amenity, can now be delivered successfully within its originally planned timescale.

#### What are the next steps?

The **Working Party** is now confirming with its selected supplier, **EarthWrights**, a final quotation, the contract and a timeline for completing **Phases 3**, **4 & 5** of the project: **Phase 3** is the removal of the old play equipment and preparatory groundwork; **Phases 4 & 5** is the installation of the modern play equipment and perimeter pathway.

The new play area will be more imaginatively configured than currently, featuring sustainable, natural equipment in landscaped surroundings.



# Playground (contd)

It will become a modern, bold and attractive focal point for the playing field, with a visual appeal in keeping with and enhancing its rural setting.

#### **Perimeter Access Pathway**



The new perimeter pathway is a key element of the project – the lottery team emphasising the need for better access to the play area and to the rest of the field for people of all abilities.

The path is designed such that a 'lap' will be 0.2 miles, enabling pupils at the

school to do 5 laps for their 'Mile-a-Day' challenge.

On behalf of the **Parish Council**, the **Working Party** would like to thank sincerely everyone who has organised events, taken part in challenges, donated or otherwise contributed to the project.



Improving the playground and developing the playing field's facilities will now help preserve this valuable village asset, leaving a lasting legacy for future generations.


# **Mobile Phone Mast Installation - Update**

Telefónica is in the process of submitting another application for a mobile phone mast on land adjacent to Little Lodge Farm on the border of Great and Little Maplestead.

The company has determined that a mast there will help to improve mobile phone services, particularly in respect of 5G and associated data provision, while also allowing the roll-out of smart energy metering access in this area of **Braintree District.** 

A previous application for a mast on this site, was refused by **Braintree DC** on 22<sup>nd</sup> September 2021 because certain material considerations, highlighted by both **Great & Little Maplestead Parish Councils**, had not been met.

The revised proposal (Application Reference: 22/02780/T56, the consultation for which closes on 17<sup>th</sup> November), is essentially as before, with a 25m (75ft) mast and antenna array in a fenced compound in the field next to the bridleway at the end of Little Lodge Lane (map below):



The **Council** has regularly received complaints from parishioners about the village's poor mobile phone coverage and asking what could be done to improve things and it agrees that this proposal would offer a welcome solution.

However, the benefits need to be balanced against potential downsides, both in terms of the mast's adverse visual impact and the potential harm 5G radiation may have on aircraft avionics and health.

There was a public suggestion at the **Council's 9<sup>th</sup> November** meeting that **BDC**, like a number of UK Local Councils, should invoke the **Precautionary Principle** regarding this installation – "When human activities may lead to morally unacceptable harm that is scientifically plausible but uncertain, actions shall be taken to avoid or diminish that harm" – until there is more Government research into these matters.

More particularly, the **Council** was concerned that, either because of a lack of due diligence or proper understanding of specific planning guidelines, a number of material considerations it had previously identified have still not been met, amongst them: incorrect identification of the field's landowner and a failure to follow **Civil Aviation Authority** safety guidelines regarding the siting of the mast within 3km of two local airfields.

The Council agreed to object accordingly.
