Playing Field Project: supplier recommendation accepted...

...after assessing the tenders.

The Playing Field Development Working Party's recommendation for their preferred supplier to replace the existing playground equipment was unanimously accepted by the Parish Council at its 29th June meeting.

The recommendation was only made after carrying out detailed studies of five submissions received during the legally-mandated tender period, using a standardised assessment template to ensure these were performed equitably and fairly.

This process left just two suppliers in contention; subsequent responses to further enquiries about each tender determined the final selection.



The preferred supplier not only scored highest by the assessment criteria but it was felt that the style and design of their play area, being both innovative and fully understanding of all children's needs, was also the best fit with the playing field's rural setting.

In other Project news...

...the choice of a supplier for the fully-accessible perimeter pathway is still under review.

Alternative quotes are now being assessed; the main requirement is that any proposed pathway is not only ecologically friendly, hardwearing and low maintenance but also offers value for money.

The Working Party is now concentrating all its efforts on revising and updating its submission to the National Lottery Fund for the approximately £75,000 now needed to complete the project.

Having reached Stage 2 of the application process, the Playing Field funding proposal has been assigned to the South East Region lottery team.

Dialogue with this team has already provided useful pointers, help and guidance on some important ways in which the submission can be strengthened and improved.

The Local Plan: Section 2

Planning Inspectors have ruled that a blueprint for development in the Braintree District until 2033 can be found legally sound.

The Planning Inspectors have examined **Section 2** of **Braintree's Local Plan**, which includes localised policies and site allocations that can be used for considering planning applications in the District. It also identifies land for economic growth, supporting infrastructure and protecting land for open spaces and community facilities.

The Inspectors' final report came after the July 2021 formal examination and a public consultation on the proposed modifications, which ended in January 2022.

After scrutinising the **Plan** and the supporting evidence, hearing from stakeholders and taking into account resident's comments via the public consultation, the Inspectors' final report concluded that **Section 2** of the **Plan** can be adopted – subject to and including their recommended modifications – and be found legally compliant and sound, subject to Councillors' approval.

A final list of the main modifications that were required accompanied the Inspector's report.

What happens now?

A revised **Section 2** of the **Local Plan** was presented for approval to the **BDC Local Plan Sub-Committee** on **Tuesday**, **5 July**. Approved, it will now be recommended to the **Full Council** on **Monday**, **25 July** for the final adoption of the whole **Local Plan**.



Clir Gabrielle Spray, Cabinet Member for Planning and Infrastructure, said: "I'm pleased we have now received the Inspectors' feedback and gone ahead with the formal approval of our **Local Plan**. It

will put us in the best possible positon to fight against speculative, unsustainable and poorly designed housing developments and give greater certainty to our local communities as to where new developments will be built and the infrastructure and facilities that will accompany them."

Green Power Consultation

Braintree District Council have opposed the National Grid's East Anglia Green (EAG) proposal for the route of a high voltage network reinforcement between Norwich, Bramford and Tilbury.

The **Council** acknowledges that the current high voltage electricity network in East Anglia doesn't have the capacity to cope, reliably and securely, with 2030's power needs but considers that alternatives, including undersea options, need to be investigated further before yet more pylons are allowed to despoil areas of open countryside.
