

Local Plan: village 'not a priority for new housing'...

Proposed sites deemed unsuitable

At its meeting on Thursday 19th June Braintree District Council's Local Plan Sub-Committee...

...considered two sites in **Great Maplestead** that, last year, had been proposed for inclusion in the **Local Plan** to meet the District's longer-term housing and infrastructure needs until **2041**.



In preparation for the meeting the two proposed sites, in **Lucking Street** and at **Long Fen**, were assessed for their development suitability.

Using **BDC's** calculation metric for determining the potential for housing – **25** houses per developable hectare – these proposals could have added **35** more dwellings to the village, increasing its size by nearly a quarter. Using another **BDC** metric – **2.3** cars per household – developing these sites could have brought another **80** cars to local roads.

The assessment of the **Lucking Street** site was that, due to its unsustainable location, access limitations, landscape sensitivity, detachment from the village form and infrastructure constraints, it should not be proposed for development allocation.

For **Long Fen** the assessment was that this site has previously been tested through the planning system and found to be inappropriate for development. Its location, access limitations and environmental sensitivities, combined with a recent history of dismissed appeals, render it unsuitable for future development allocation.

In summary, the assessments concluded that, as **Great Maplestead** has limited local services and infrastructure, **the village is not considered a priority location for new housing growth** within **Braintree District**.

Recommendations accepted

The recommendations to the **Sub-Committee**, that **neither site should be allocated for development**, were therefore accepted and will be carried through to the next consultation phase this autumn. Before then there will be an opportunity for further sites to be put forward for consideration.

Waste Recycling - the decision...

Following a public consultation, in which almost 8,000 residents took part, BDC's Cabinet meeting on 27th May agreed changes to waste recycling and bin collections; these will come into effect on 1st June 2026.

The new arrangements are to try and help get the District to over 60% recycling, with a key aim of recycling more food waste – a 2024 study found that almost a third of black bin waste was food.

The plans include the reintroduction of hard-copy **Recycling Calendars** – good news, because many people relied on these as a source of information and the new collection arrangements will be more complicated than the current ones, viz:

- Green waste as now once a fortnight, for those subscribing.
- Food waste will stay the same weekly, using the current caddies.
- Black bins (residual waste) will be collected only every 3 weeks.
- Recycling will no longer be in clear sacks but instead in 2 new wheelie bins with alternating fortnightly collections: paper and card in one bin and all other recycling, including glass, in the other.



There will be bespoke arrangements for flats and homes that do not have space for extra wheelie bins. The collection days will be announced, and the new Recycling Calendars issued, in spring 2026.

Playground Safety Report issued

The annual Safety Inspection of the Playing Field's children's play area was carried out by an inspector from the Royal Society for the Prevention of Accidents (RoSPA) Play Safety team on 5th June.

As expected, no problems or issues were found with any of the current play equipment, which only received its completion sign-off in March 2023.

A few minor items that were noted for action were: parts missing from the litter bin, the looseness of

some of the perimeter fencing supports and the ineffectiveness of the main access gate closer, which has subsequently been adjusted to now completely close the gate after use.



Users of the play area are reminded that, for safety and hygiene reasons, no dogs are allowed inside the fenced enclosure. To avoid parents having to leave dogs alone outside,



tied to the boundary fence, while they supervise their children, one of the original benches has been moved to a position that allows good visibility of the entire play

area so parents can remain outside with their dogs.

Playing field users are also reminded that, to comply with the **Council's Safeguarding Policy**, they should show due consideration for others using this valuable community asset, whilst ensuring that their behaviour and interactions – in particular with young children and vulnerable adults – are both respectful and appropriate.

Bus Service Update

Central Connect have confirmed that they have retained the contract for operating the on-demand DaRT3 local bus service for a further 12 months, from the end of June.

The **DaRT3** service does not run to a regular, or published, operating timetable – it needs



to be pre-booked. The **Booking Centre** is open **8.00am** to **6.00pm** Monday to Saturday and bookings must be made **by 6.00pm the day before you wish to travel.** All bookings are subject to availability.

Charging remains as before, the fare being £3 for any single journey. One significant change however is that, now, booking is no longer conditional on there being a minimum number of passengers from any particular location.

DaRT3 operates between **6.00am and 8.00pm** Mondays to Saturdays. Concessionary bus passes are accepted after 9.00am Monday to Friday and all day on Saturdays.
