


Cllr Harris Report/Action Plan – January 2022

Communications

1. Website/Facebook

❖ Report/Review:

- The Council’s website continues to be a valuable source of local information.
- During the course of last year it was regularly updated with the ongoing changes to the **COVID-19** guidelines; links to the Government and NHS websites were maintained to enable users to keep abreast of relevant official information.
- Averaged across the whole of **2021**, unique visitors to the site were over **725** and it was visited just under **1030** times each month.
- As the chart below shows, after **6 years of successive growth** in visitor numbers and site visits since the Council took control of the website, activity declined slightly, back to 2019 levels, during the past year:



- Some of the reasons for this may be that:
 1. There was less need than in 2020 for people to visit the site to check changing national Covid actions and local community help initiatives.
 2. Apart from the **Fun(d) Day** and **Quiz**, very few village events took place during 2021; this in turn meant that there was less frequent updating of event information on the site, which is one of the main visitor attractors.
 3. The Council placed a greater reliance on Facebook to get its important messages to a wider audience more quickly, resulting in a shift in some visitors’ attention.
- The Council’s Facebook page has continued to prove a valuable asset during the year, in particular its link with the village’s Maplestead Mates page enabling important information to be quickly and widely distributed across the parish.
- **52** separate posts were made on the Council’s page during **2021**, achieving a total reach of **7,903**, each post reaching on average around **152** people.
- The top three posts by reach were:
 1. 665 – Simon Last’s Radio Essex appearance (also with 84 comments!)
 2. 595 – Fly tipping in Gestingthorpe Road
 3. 387 – Overgrown verges obstructing sightlines on Castle Heddingham Rd.
- The three posts with the least reach were:
 50. 36 – Covid Essex website information
 51. 33 – Essex Libraries Consultation
 52. 10 – Covid Plan B update (!)
- Many more however will have seen the Council’s posts on Maplestead Mates – unfortunately, this information cannot be publicly accessed or easily extracted.

❖ **Action Plan:**

- Regular updating of the website and associated links will continue in 2022.
- The Council's Facebook page will also carry links to the website when more in-depth information than can sensibly be carried on Facebook needs to be communicated, in order to bring it to the widest possible attention.

❖ **Report:**
