8. PUBLIC QUESTION TIME

A number of questions were raised regarding the proposed withdrawal of the village bus service F315 and these will be directed to County Councillor Schwier for attention. The council advised parishioners to respond to the on-line consultation, with the Clerk obtaining hard-copy versions for those unable to access on-line.

Comment: Recent hedge cutting on FP15 has left debris on the ground, which makes the pathway difficult to navigate. The council confirmed they would contact the landowner.

Question. Could the council investigate over-hanging trees/vegetation on the highway in Dynes Hall Rd. The council will contact relevant landowners to request clearance as appropriate.

Comment. Noise from the recent Essex Gun Shoot appeared to continue for long hours over consecutive days, including Sunday. The council confirmed they would investigate what permissions were in place and if these had been exceeded then a letter would be sent to the organisers.

Comment. Parking of vehicles on the corner of Lucking St/Toldish Hall Rd is causing a roadside hazard, and blocking access to the dog waste bin. The council will contact the local PCSO and ask them to contact vehicle owners.

9. PROGRESS UPDATES

The Clerk pre-circulated a report on actions since last meeting, and also advised that an approach had been received for Great Maplestead to join together with the parish of Gestingthorpe to host a village fete bi-annually, alternating the location. It was agreed that a note would be included in the Parish News to gauge parish interest and inviting volunteers.

Cllr.Last advised that the final phase of the playing field project is now complete with the National Lottery providing the final amount of grant funding, following a review of council procedures for the project. The council agreed to consult with the parish with regards to the next phase of refurbishment at the village playing field with items 10.3.1 – 10.3.4 all suggested ideas to review.
