Communications

1. Website/Facebook

❖ Report/Review:

- The Council's website was moved to a new, free, hosting platform last
 February and the core content was amended in September to include an
 Accessibility Statement; this was required in order to meet legislation set out in
 the 'Public Sector Bodies (Websites and Mobile Applications) Accessibility
 Regulations 2018', which requires Local Councils to ensure their website meets
 standards set out in the Web Content Accessibility Guidelines version 2.1
- During the course of the year the website was regularly updated with details about the COVID-19 pandemic and resulting local community help initiatives; links to the Government's and NHS's sources of information were established to enable users to keep abreast of the ever-changing guidelines and updated Tier changes and lockdown requirements.
- High usage in the first three months of the year (averaging just over **3000** visits/ month) would suggest it was considered a valuable source of this information.
- Across the whole of last year, monthly unique visitors to the site averaged over 940, 14% up on 2019 and it was visited just under 1500 times a month on average, up 31% year-on-year.
- However, the average monthly number of pages accessed fell slightly (about 3% fewer than 2019) to just under 6850 a marked dip during the summer months possibly resulting from the lack of social events information to peruse...
- More details on the annual website usage, along with comparisons to previous years, can be found in **Appendix 1**.
- The Council's Facebook page also proved to be a valuable asset during the year, its link with the village's Maplestead Mates page enabling important information to be quickly and widely distributed across the parish.
- 58 separate posts were made on the Council's page during 2020, achieving a total reach of 22,719. This figure however includes two posts the poisoned Labrador and traveller incursion ones which alone accounted for some 17,100 views. Excluding those outliers, each post reached on average around 100 people.
- Many more however will have seen the Council's posts on Maplestead Mates unfortunately, this information cannot be publically accessed or easily extracted.

❖ Action Plan:

- Regular updating of the website will be continued in 2021.
- The Council's Facebook page will continue to carry links to the website when more in-depth information than can sensibly be carried on Facebook needs to be communicated, in order to bring it to the widest possible attention.
