The bank reconciliation incorrectly includes reconciling entries relating to accrued income. The Council accounts on a receipts and payments basis but the VAT refund due from HMRC for the 2013/14 year totalling £754 has been included in Box 3. The refund was received in April 2014 and should be accounted for as a 2014/15 receipt. Receipts in the year and the cash balance at the end of the year are therefore overstated by £754, please ensure this is corrected when reporting the 2013/14 results and closing position in the 2014/15 Annual Return.
